New Business: Resolution Adopting Water and Sewer Asset Management Plan

Motion was made by Lewis, seconded by Mashburn to approve the Resolution Adopting Water and Sewer Asset Management Plan. Motion carried. Vote: 5 to 0.

New Business: Discussion on American Rescue Plan

Town Manager Summer Woodard said the information that has been available indicates that funds are unable to be spent on pension funds but are available for offsetting revenue loss, hazard pay, water and sewer projects, and other infrastructure projects. She said one caveat is that you may not use the fund to offset lowering of taxes.

New Business: Discussion on Vacation and Sick Leave Accrual for Public Safety

Fire Chief Ben Ormond presented this item. The proposal was to base sick and vacation accruals on time worked by fire and police employees.

Motion was made by Lewis, seconded by Mashburn to approve the Vacation and Sick Leave Accrual Rates for Public Safety. Motion carried. Vote: 5 to 0. A breakdown of the proposal is attached.

Town Manager Summer Woodard said the owners of Yonder did not qualify to sell alcohol for onsite consumption under the referendum that was approved by voters in 2006. She said the only way to change the approved wording would be to have a referendum in the fall.
