A.) Budget Amendment

Motion was made by Mashburn, seconded by Lewis to approve the consent agenda for May 18, 2021. Motion carried. Vote: 4 to 0.

New Business: Revenue Update on Town of Franklin Fiscal Year 2020-2021 Budget

Town Manager Woodard presented this item.

She said that if the books were closed today, the Town would be better than previously expected. The numbers are as follows.

General Fund Revenue: \$3,529,976.53 compared to current expenditures of \$3,406,599.44 Fire Fund Revenue: \$938,845.55 compared to current expenditures of \$\$627,962.34 Enterprise Fund Revenue: \$3,538,523.67 compared to current expenditures of \$2,749.320.97

She said that there will be other expenses come in before June 30 but that the Town will be in good financial standing.

New Business: Discussion on Tow of Franklin Proposed Budget for Fiscal Year 2021-2022

Town Manager Woodard presented this item. Proposed budget and the Manager's message is available for inspection at Town Hall and at www.franklinnc.com.

Land Use Administrator Justin Setser and Police Chief Bill Harrell gave a presentation on the need for a Code Enforcement Officer.

Council Member Collins said that he wasn't sure it was necessary to have a full-time employee in the position and that it may be better suited as an administrative position instead of a sworn officer. He said the money that has been budgeted should remain in the budget until a new manager can decide how to move forward.

May 18, 2021 meeting continued,

Council Member Horton said that Setser has too much on his plate as is and that the Town needs somebody. He said he leans towards a sworn officer.

Council Member Lewis said that he thinks it's needed and that the money should be left in the budget for a new manager to decide on the way forward.

Council Member Mashburn said she agrees.

Mayor Scott said he thinks the Council should vote on the position tonight.

Council Member Mashburn said she didn't think there was anything to vote on tonight.

Town Manager Summer Woodard read a letter from Council Member Culpepper. He said he'd like to see Pickin' on the Square more inclusive with Main Street merchants, he doesn't want to cut round about improvements, a skatepark could work at Memorial Park or the old service station property, and that a 2% COLA is necessary for retention and recruitment of employees as well as more intown recreation opportunities for employees and their families.

Council Member Horton said that he thinks the budget as presented reflects the priorities of the Town Council.

Motion was made by Lewis, seconded by Culpepper to appoint Justin Setser as Interim Town Manager effective as of June 8, 2021. Motion carried. Vote: 5 to 0.
